- For foreign nationals whose entry to Japan has been delayed due to the impact of the COVID-19 pandemic, the Immigration Services Agency of Japan has taken special measures to extend the validity of the certificate of eligibility (hereinafter "Certificate") required to clear immigration (refer to "Previous policy" below).
- In light of the global outbreak of the omicron variant and measures subsequently taken by the Agency to temporarily bar the entry of foreign nationals as an emergency precautionary measure, the Agency will take measures to further extend the validity of Certificates (refer to "New policy" below).
- * For applications for Certificates made on or after July 31, 2022, and before the date designated by the Immigration Services Agency of Japan with no changes made since the previous application, an expedited new Certificate will be issued, as a rule, when the applicant submits (1) the previously issued Certificate (original or a copy) and (2) a statement of reasons prepared by the accepting organization, etc. See here for details.
